Competitors without a valid ECPHRF Rating Certificate must provide a copy of a valid rating certificate. Unmeasured boats will be assigned a rating by the Race Committee

### Registration and Fees

The cost to race is \$30.00 in advance and \$35.00 on the day of the event. To register please complete and mail the attached entry form. No registrations will be taken after 13:30 hrs on the day of the event.

### Overnight Docking

Overnight docking is available for visiting boats.

### Awards

Prize flags will be awarded as follows for each Fleet:

7+	1 <sup>st</sup> , 2 <sup>nd</sup> , 3 <sup>rd</sup>

### Rules

The Racing Rules of Sailing 2009 – 2012 will govern all races.

### Notices to Competitors

All notices to competitors will be posted on the "Official Race Board" located in the clubhouse no later than 14:00 on the day that it takes effect.

Skippers meeting will be held at 13:45

### Signals made Ashore

Signals made ashore will be displayed at SPSC clubhouse lawn

### Starts and Finishes

Races will be started using Rule 26. The starting line will be between the blue RC flag on the signal boat and the orange pin mark. The finish line will be perpendicular to the last leg of the race. Cross the finish line leaving the orange pin to port.

### Starting order & Class Splits

Final class splits will be posted on the "Official Race Board" located in the clubhouse no later than 14:00hrs the day of the event

### Radio Communications

The RC will communicate information on and monitor VHF channel 68.

### Boats Retiring

As a courtesy to the RC we ask all competitors withdrawing from the race to report to the RC Boat.

### Protests

Protest forms will be available 20 minutes after the RC boat docks. Protests must be delivered to the office within 1 hour of the RC boat docking.

### Course #1

From the start line, sail 3.9nm 132°mag to the Belle River mark leaving it to port, sail 9.3nm 9°mag to R24 leaving R24 to port, sail 7.9nm 214°mag to the finish line.

Total distance: 21nm.

### Course #2

From the start line, sail 7.9nm 34°mag to R24 leaving it to port, sail 7.3nm 235°mag to R6 leaving it to port, sail 2.9nm 144°mag to the finish line.

Total distance: 18nm.

### Course #3

From the start line, sail 5.9nm 26°mag to R20 leaving it to port, sail 5.3nm 235°mag to R6 leaving it to port, sail 2.9nm 144°mag to the finish line.

Total Distance: 14nm.

### Course #4

From the start line, sail 2.9nm 324°mag to R6 leaving it to port, sail 2.5nm 223°mag to Dp7 leaving it to port, sail 3.4nm 98°mag to the finish line.

Total distance: 8.8nm.
