NOTE: (Initiation Fee) Club policy for pervious Family Members changing back to Family form another classification. “ When a Member abandons his/her Family Membership for another classification of membership (Senior, Non-resident or Associate), he/she may later apply to regain his/her resigned Family Membership by paying the difference in annual membership dues between the classifications for his/her time at that other classification. This amount shall not exceed the Family Membership Initiation Fee. Then on the approval of the Board the applicant may be returned to the Family Membership classification. When a Member (Associate, Non-resident, Intermediate, or Junior) who has never previously held a Family Membership applies for a change to Family Membership, one half of his/her dues paid up to that time will be credited to the Family Membership Initiation Fee. On payment of the balance of fees and dues, and with the approval of the Board, the applicant may become a Family Member.”
