Provisions stated in this document replace similarly numbered provisions in the SSI.

2 NOTICES TO COMPETITORS

Notices to competitors will be posted on the club website www.southportsailingclub.com.

4 SIGNALS MADE ASHORE

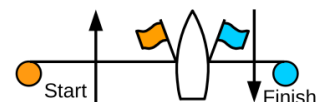
Signals made ashore will be displayed on the flagpole at the northeast corner of the property.

7 RACING AREAS

The racing area will be approximately 2nm due north of Pike Creek.

8 THE COURSES

8.4 For courses L, LA and TL, the starting line and finishing line will follow the diagram to the right This changes the course diagrams for courses L, LA and TL in RRS S. Both the starting and finishing marks may be in place during a start or a finish.



9 MARKS

9.1 Marks 1, 2p and 2s will be red cylinders.

9.2 The offset mark 1a will be an orange ball .

9.3 New marks as provided in instruction 12.1 will be a yellow cylinder.

9.4 The starting marks will be the race committee signal boat at the starboard end and a red cylinder at the port end.

9.5 The finishing marks will be the race committee signal boat at the starboard end and a red ball at the port end.

11 THE START

11.1 The starting line will be between a staff displaying an orange flag on the starboard end signal boat and the course side of the port-end starting mark.

12 CHANGE OF THE NEXT LEG OF THE COURSE

12.1 The course will not be shortened to less than two legs. The leg to 1a is not considered a leg of the course for this purpose. This changes SSI 12.4.

12.2 If the windward marks 1 and 1a are changed, mark 1 will be replaced with a yellow cylinder and 1a will be replaced with an orange ball.

13 THE FINISH

13.1 The finishing line will be between a staff displaying a blue flag on the starboard end signal boat and the course side of the port-end finishing mark.

15 PROTESTS AND REQUESTS FOR REDRESS

15.1 The protest time limit is 30 minutes after the race committee boat docks.

15.2 Hearing requests and requests for redress **must be filed online** using the form provided within the protest time limit. The link can be accessed from QR codes posted around the regatta site or from the event website at:

15.3 Notices will be posted online within 30 minutes of the protest time limit to inform competitors of hearings in which they are parties or named as witnesses (the link is available on the event website and here:
