### 1 RULES

- 1.1 The regatta will be governed by the rules as defined in The Racing Rules of Sailing.
- 1.2 The SPSC Members Code of Conduct and Safe Sport Policy apply see the SPSC By-Laws Handbook.

### 2 ELIGIBILITY AND ENTRY

- **2.1** The regatta is open to pre-registered boats of the PHRF-Spinnaker, PHRF-JOG, or Shark classes.
- Other classes are welcome to their own start with a minimum of 3 boats, at the discretion of the Organizer.
- In a PHRF (JOG or Spinnaker) class, a boat must have a currently valid MidwestPHRF rating certificate. Regatta will be scored with appropriate MWPHRF handicaps.
   Sharks will compete in one-design configuration, with PHRF rating of BHCP & HCP =243, DHCP =239, and NSHCP =252.
- 2.4 Competing boats must have VHF radios capable of transmitting and receiving CH16 and CH69.
- 2.5 Eligible boats must register by submitting a completed <u>SPSC Harvest Moon Registration Waiver</u> (see the bottom of the NOR) and fees to SPSC.

### 3 FEES

- 3.1 Registration fees will be \$40/boat, payable on the day of the regatta.
- 3.2 Registration includes 4 tickets for post-race chili, and beer (as long as it lasts). Additional tickets are available for \$10/each.
- 3.3 Registration includes use of the SPSC dry-sail crane if required. (SPSC members to assist/operate.)
- 3.4 Registration includes free assigned dockage at SPSC for competitors from Friday Sept 19 to Sunday Sept 221. Please contact SPSC Harbourmaster if a longer stay is needed.

### 4 SCHEDULE

- 4.1 Sailing Instructions (SI's) will be available no later than 5PM Thursday Sept 18, and posted online and on the SPSC bulletin board. (Any changes to the SI's will be posted on the SPSC Noticeboard in the clubhouse sunroom. SI's will carry specific info on courses to be sailed for all classes.)
- 4.2 The race will be on Saturday Sept 20th. First warning signal no earlier than 2PM.
- 4.3 The awards presentation will be at SPSC and will follow racing where possible.

5.1 Racing will be around a long-distance, Lake St Clair course as per Sailing Instructions. Weather conditions will be considered by the RC to determine the length of the course.

### **6 PENALTY SYSTEM**

6.1 RRS 44.1 is changed so that the Two-Turns Penalty is replaced by the One-Turn Penalty.

### 7 SCORING

- 7.1 PHRF racing per ToT handicapping.
- 7.2 Finishes will be listed on the SPSC Bulletin Board after the regatta.

### 8 PRIZES

- 9 Minimum of one prize for every class, per 3 boats competing.
- 10 SPSC perpetual trophies for First to Finish, Best Corrected and First Shark to Finish.

### 11 RISK STATEMENT

- 11.1 As per RRS3, 'the responsibility for a boat's decision to participate in a race or to continue to race is hers alone'.
- 11.2 The organizing authority will not accept any liability for material damage or personal injury, or death sustained in conjunction with or prior to, during, or after the regatta. Further, in an effort to adhere to the highest standards of competitive behaviour, and in keeping with new guidelines published by Ontario Sailing Association, no bullying, physically or verbally aggressive, or disrespectful behaviour will be tolerated from any skipper or crew from any boat participating in the Regatta, regardless of if they are SPSC members or not.

### 12 INSURANCE

12.1 Each participating boat shall be insured with valid and sufficient third-party liability insurance.
